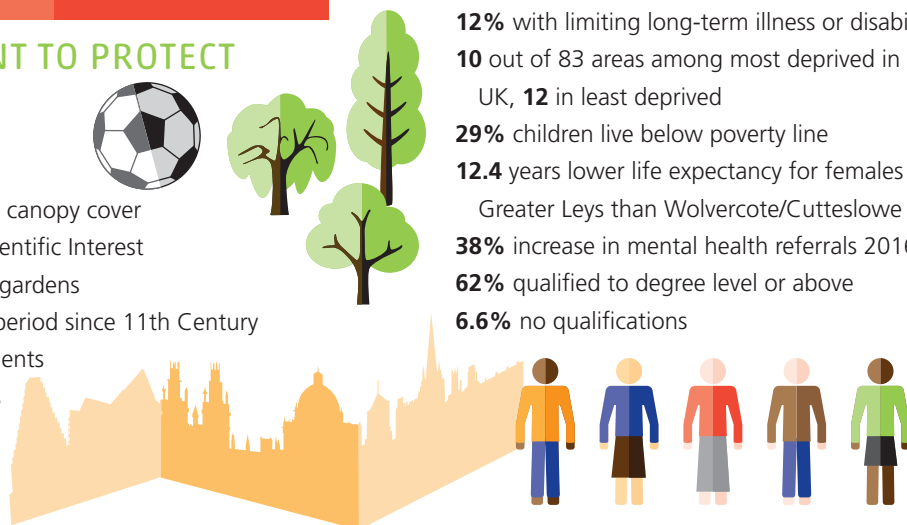

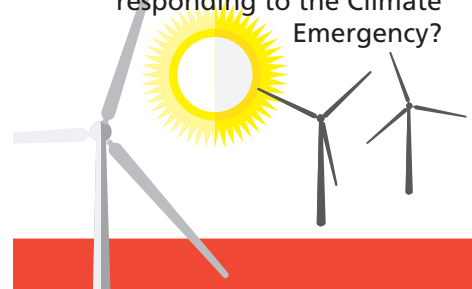

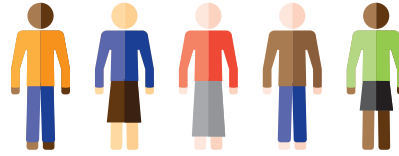
URBAN DESIGN
