1. Welcome and apologies

2. Draft minutes of the last meeting & matters arising

o Minutes of the last meeting were agreed.

3. Oxford City Council update

(Caroline Green – Chief Executive, Oxford City Council)

- Cllr Susan Brown was attending the <u>UKREiiF event</u> in Leeds. Alongside colleagues from <u>OxLEP</u>, the <u>Oxford to Cambridge pan-Regional Partnership</u> and the Fast Growth Cities Group
- An update was shared, focus items included:
 - Local elections The Council remains as a no overall control administration; with Labour as the largest group, Liberal Democrats as the second largest.
 - The makeup of the Cabinet members and their responsibilities had been announced.
 - The Council will carry on the programme of works aligned with the 2024/2025 Budget.
 - Key decisions of interest will continue to be supported and enabled through cross party conversations.
 - Cllr Mike Rowley has been sworn in as <u>Lord Mayor of Oxford</u> for 2024/2025.
 - Work is progressing on the:
 - Blackbird Leys Regeneration programme.
 - Oxford Covered Market and Market Street redevelopment project.
- Oxford United Football Club A city centre celebration of the club being promoted to the football league Championship has taken place. An event organised within 48 hours by the Council in partnerships with Blue Light services and the County Council, alongside other key stakeholders.
- Housing challenges and pressures A national, as well as local, challenge. The Council has mitigation in place however pressures continue. The Council is continuing to lobby Government.

4. Local Enterprise Partnership Planning

(Robin Rogers - Programme Director Partnerships & Delivery, Oxfordshire County Council)

(Richard Byard – Director of Business Development, OxLEP)

o Provided further insight on the process being taken, transition of the OxLEP team to the LEP.



- Commented that it is important to remember that this is not 'new work'; OxLEP has already been delivering with the County as a partner.
- o Partnership for Future Oxford Partnership stakeholders to import corporate knowledge and experience across the wider 'family relationship'.
- o A business as usual approach, and delivering community led projects.

Key discussion points:

- Engaging city schools and colleges with businesses (e.g. opportunities for young people to move onto their next best step; 'Education to Economy', 'Skills Landscape'
- o a complex and financially restricted skills system
- o skills pathways for education (this is where our workforce comes from) to employment
- o challenges for schoolwork experience opportunities
- o more inclusivity in supporting both ends of the landscape 'great economy'.
- Level of business support to help businesses survive (pre-start & SME)
- o supply chain for local people
- o an interest in a 'Brand for Oxford'
- T Levels are growing fast in the further education system. There is a need for Businesses to understand this growth and engage with placements.
- o It was noted and welcomed that the County Council was taking on the LEP transition going forward, alongside the well-functioning OxLEP. Both are working well together as part of the transition, whereas nationally it may not be so everywhere.
- The ability to attract and leverage funding is important
- o Proposed that the OSP considers delivering a future Apprenticeship Summit.
- Potential for opportunities to bring employment, education, training, knowledge and retention together on the inclusivity front. There are common issues affecting the base family level. Understanding what, where and who to make the best use for targeted resources in the city is important. There is a need to drive this agenda forward as much as possible.
